1. Services: U Can Recycle WA Pty Ltd will regularly pick up your collected eligible containers from your premises.

- We offer bin hire services for recycling eligible containers.
- Deposit is required for bin hire.
 - Refundable deposit of \$20 for each 240 L bin
 - Refundable deposit of \$50 for each 360 L bin
 - Refundable deposit of \$100 for each 660 L bin.
- Our bins must only be used for eligible beverage containers accepted under the Containers for Change WA scheme.
- Our bins must be used continuously, not left empty.
- If there is no booking for bin collection within 2 months, we are within our rights to take the bin back.

2. Service conditions:

- A service fee of 2 cents per eligible container will apply.

For example: if you receive \$24 in your account (Your total containers could be calculated: $\$24/0.08=300$ (containers))

- Bins are to be secured either inside a gated area or kept locked with our supplied combination lock and trace.
- Customers will be responsible if the bins provided are damaged or stolen.
- The cost of repairing or replacing any lost or damaged bins may be deducted from the customer's bin deposit.
- We do take crushed cans and please try not to break glass bottles.
- Collection date will be agreed upon.
- It is agreed to have access available for bins collection.

3. Payment:

- **Home Collection & Container4Change (C4C) Accounts:** Payment will be processed after the containers have been counted. Counting and payment processing may take **2–5 business days** from the collection date.
- **Commercial Customers:** Payments will be made **monthly** by bank transfer to the customer's nominated bank account.
- **A monthly remittance advice will be emailed to the nominated email address for commercial customers who receive payment by bank transfer.**
- If the bins contain a large amount of rubbish or ineligible containers, disposal fee will be deducted from the payment.

4. Termination:

- A month's notice must be given for cancellation of service with good reason in writing.
- All the bins must be returned to us in good condition.
- The refundable bin deposit will be refunded once all bins have been returned in good condition, subject to any deductions for loss or damage in accordance with this agreement.
- Any collection issues must be notified in writing and two days are given to resolve and make good.
